



DANB Parent/Guardian Consent Form

This form will be accepted through Dec. 31, 2021.

To be completed by the parent or guardian of DANB exam candidates who are under 18 years old

I , as parent or legal guardian of (the "DANB Exam Candidate"), understand, acknowledge and consent to this minor individual applying to take exam offered by the Dental Assisting National Board, Inc. ("DANB").

Further, I understand, acknowledge and agree to the following:

For all DANB exams, whether administered at a Pearson VUE test center or by Pearson VUE's online proctored test delivery method:

- As a DANB Exam Candidate, this individual must provide first name, last name, street address, email address and cell phone number ("Personal Information"). I grant my permission and authorization for the collection, use and disclosure of the DANB Exam Candidate's Personal Information by DANB to DANB's testing vendor, Pearson VUE.
- As a DANB Exam Candidate, this individual is subject and will adhere to the policies in the current *DANB Candidate Handbook* (<https://www.danb.org/Become-Certified/Exams-and-Certifications.aspx>) and the tenets of *DANB's Code of Professional Conduct* (<https://www.danb.org/The-Dental-Community/Professional-Standards.aspx>).

For all DANB exams administered via Pearson VUE's online proctored test delivery method:

- If the DANB Exam Candidate chooses to take a DANB exam in Pearson VUE's online proctored environment rather than in person at a Pearson VUE test center, as the DANB Exam Candidate's parent or legal guardian, I must be present in the room in which the DANB Exam Candidate will be testing for the exam check-in process and present my own valid government-issued ID. After the ID check, the parent/guardian will be required to leave the room and may not re-enter the room or communicate with the DANB exam candidate for any reason while the exam administration is in progress.
- At the start of the online proctored DANB exam administration to the DANB Exam Candidate, I agree to provide verbal consent on behalf of the DANB Exam Candidate to the following:
 - The DANB Exam Candidate will use their mobile phone to provide the following to the Pearson VUE greeter:
 - A headshot photo
 - A photo of the front and back of their government-issued ID
 - A 360-degree scan of their exam space
 - The DANB Exam Candidate will be subject to:
 - Application of facial comparison technology to verify identity
 - Video- and audio-recording during the exam administration for exam security purposes
 - Items in the exam space are subject to visual inspection by the greeter before the exam administration and by the exam proctor during the exam administration.
 - Religious apparel and any comfort aids are subject to visual inspection by the greeter before the exam administration and by the exam proctor during the exam administration.
- If the DANB Exam Candidate's testing session is terminated by the proctor for reasons as outlined in the DANB Candidate Handbook (e.g., cheating, disruptions during an online proctored exam), the DANB Exam Candidate:
 - May be subject to disciplinary action as outlined in DANB's Disciplinary Policy and Procedures (<https://www.danb.org/The-Dental-Community/Professional-Standards.aspx>)
 - Will need to submit a new DANB exam application with any required exam eligibility documentation and current fees, if they desire to test in the future

I certify that I am 18 years of age or older, the DANB Exam Candidate's parent or legal guardian and, as such, have the right and authority to make decisions for this minor child that may affect their well-being. I further attest to having read, fully understand and agree to the terms of this Consent Form and I sign it voluntarily.
